Realtor services will include the following:

- I. Assessment of each parcel
 - Determination of appropriate listing price
 - Estimated time on market
- II. Marketing of parcels
 - Listing of parcels via MLS and associated online and published marketing channels, including photographs of parcels
 - Signage placed on each parcel
 - Communicating directly with prospective buyers to negotiate acceptable terms of purchase
- III. Communication and Closing
