The project generally consists of approximately 3,900 LF of 6" water line, 300 LF of 4" water line, 100 LF of 2" water line, 8 fire hydrant assemblies, 2 blow-off assemblies, 28 water line reconnections, 12 water service reconnections, and associated work tasks for a complete and proper installation.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated on the Bid Form.

Bidders must deposit security with all bids. Provisions of the security shall be as described in the Information for Bidders.

Performance and Payment Bonds, each in the amount of 100% of the contract price will be required of the successful bidder.

Funding for the project shall be provided via grants from the S.C. Department of Commerce (CDBG Program), SC DHEC SRF, and local match funding provided by the Town of Lockhart. SRF requirements for American Iron and Steel (AIS), Debarment Certification, and David-Bacon Wage Rates will apply to this project.

This project is being funded in whole or in part by the Community Development Block Grant Program (CDBG). All federal CDBG requirements will apply to the contract. **All contractors and subcontractors are required to be registered in the federal System for Award Management (SAM) prior to the contract award.** Bidders on this work will be required to comply with the President's Executive Order No. 11246 & Order No. 11375 which prohibits discrimination in employment regarding race, creed, color, sex, or national origin. Bidders must comply with Title VI if the Civil Rights Act of 1964, the Davis-Bacon Act, the Anti-Kickback Act, the Contract Work Hours and Safety Standards Act, and 40 CFR 33.240.

Bidders must also make positive efforts to use small and minority-owned business and to offer employment, training and contracting opportunities in accordance with Section 3 of the Housing and Urban Development Act of 1968. Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the contract.
